## REQUIREMENTS

1. Completed application.
2. A brief written statement from the applicant indicating professional objectives, the reasons why this scholarship should be awarded to the applicant and any special factors that the Committee should consider.
3. A letter of recommendation by a faculty member of the law school attended by applicant which may be sent directly to the Committee but must be received by the Committee before the application deadline.
4. A copy of the applicant's most recently filed Federal income tax return and a copy of W2s and 1099s for subsequent calendar years.
5. Attendance at the Justinian Scholarship and Installation Dinner is mandatory to receiving the scholarship. The dinner is usually held in mid to late May.

The applicant may include a more detailed breakdown of income and expenses if he or she believes that information regarding financial need is important for the Committee to know.

All applications and recommendations must be received no later than April 13<sup>th</sup>, 2012.
